

Summary of Advocacy Committee Meeting
October 2, 2025 1 pm Eastern

1. Welcome and Introductions

Steve Arms, Chair, welcomed everyone to the meeting. Attendance is recorded in Attachment 1 – 5 Voting members (Quorum) and 3 Associate members.

The agenda was approved by unanimous consent. There was a correction to the month for the minute review – it is September.

A motion was made by Devon to approve the September 4, 2025, with a few editorial changes. The motion was seconded by Janice and there was no further discussion. Mike Delaney abstained from the vote and the other voting members voted For. The minutes were approved for posting.

2. Boston Conference

Registration for the conference opened today – 10-2-25. Committees are now sending in agendas for their meetings.
