Summary of Advocacy Committee Meeting May 1, 2025 1 pm Eastern

1. Welcome and Introductions

Steve Arms welcomed everyone to the meeting. Attendance is recorded in Attachment 1. The agenda was approved by unanimous consent (see Attachment 2) after agreeing to postpone the newsletter update until Sharon could join the meeting late. The minutes from April 3, 2025, were unanimously approved after a motion by Mike, seconded by William.

2. Updates

Board Discussion about Advertisements in Newsletter

The Board approved the inclusion of newsletter ads in concept and referred the issue to the Finance Committee to determine appropriate charges. The issue of notifying potential advertisers of this availability remains to be addressed.

Need for New Committee Members in Advocacy

Participants agreed to first ask the current Associate Members about becoming Voting Members. Paul noted that we should add an odd number of new Voting members to make achieving a quorum easier (there is currently an even number of Voting members). Further discussion addressed questions about the need for regular availability or if occasional absences were acceptable.

3. Conference Issues

There were no conference issues to be addressed.

4. Review Draft Letter to Cannabis Regulators Association (CANN-RA.org)

Participants wordsmithed the draft letter, and left it much improved. Jerry noted that he will seek out a cannabis speaker for one of the EMS sessions in St. Louis.

5. Newsletter Update (delayed per agreement)

With Sharon's arrival, the update was that at least two articles remain outstanding, but all others were submitted.

6. Discuss Adding AB Newsletter Links to the TNI Website

This possibility was raised by Paul, from a lab's audit finding. Jerry explained that only a very few ABs have newsletters or post easy-to-find public updates to their websites, but that he does collect those updates weekly for a different purpose. The group's consensus was that putting such information on TNI's website would require more investment than the benefits to be obtained, as each AB does communicate the information with its accredited labs already. No further action is needed.

7. Updated NELAP Vision and Outreach Plan

This issue is tabled until the Board determines how to proceed with updating its Strategic Plan that may include seeking ways to assist EPA's Drinking Water certification program if budget upheaval endangers that required function.

8. New Business

There was no new business offered.

9. Next Meeting
