#### **Review of July 2022 Minutes**

#### **Response to Comments**

Prior to the July ATEC meeting comments from the AC and Dr. Kircher were received for committee consideration. During the July meeting the AC comments /observations were resolved.

The comment from Dr. Kircher however was tabled till our August meeting. The comment requested the addition of a parenthetical regarding conversion of GOA units to mm<sup>2</sup>. It appears that there are two versions of the method cited in the DS despite having the same EPA reference. One requires the GAO units to be mm<sup>2</sup> while the other requires the GAO in units of square microns. In either case the calculations presented in that version of the method provide for the appropriate resulting asbestos concentration.

Michelle, following the July meeting, contacted EPA representatives who acknowledge the error in the published method. At this time, they have no intention to correct the error other that to have presented an "errata" in 1995 to clarify the issue. The members of the committee present supported the EPA suggestion that the citation simply be modified to include the errata of 1995. This suggested is being proposed to resolve Comment 54 on the R2C document and is presented below:

As a quorum was not present, an e-mail ballot including a motion and second to approve this response will be sought.

After approval of the R2C, the AC and Dr. Kircher will be advised of the committee decision. The R2C will then be posted on the TNI website, and the process requirements of SOP 2-100 will continue.
