Work Group discussion on SRM Availability

Robert has collected past and current information regarding SRMs, as well as their availability and distributed said information to the Work Group members (Robert, Michelle, Maria, and Myron Getman) for further discussion, however any further discussions have yet to occur. Kathleen, in her role as an assessor, pointed out the need to address the issue as labs are in a position currently not being able or will soon be unable to comply with EL-V1M3 requirements.

After significant discussion, it was obvious that this issue of the unavailability of SRM materials and hence the potential inability of laboratories to comply with EL-V1M3 will require considerably more effort. It was determined that as opposed to reopening the module, the development of an implementation guidance document to present potential for use of "equivalent (as per EL-V1M3)" materials was the preferred approach.

The existing work group will develop a plan and define the steps necessary to develop such a guidance document and will brief the full committee during the August meeting. At that point a separate work group will be formed to develop said guidance. It is anticipated that the work group will include, as available, all the members of the ATEC.

Old/New Business

No new or old business was discussed.
