Introduction and Current Membership

The current committee membership was presented and those present were introduced. New members are being sought, and Associate members are welcome to fully participate in Standards development. The CEC is currently balanced and without dominance.

Review of Recent Activities

In addition to addressing CEC SIR and general committee administrative matters, the committee spent most of its efforts on reviewing and developing proposed changes to EL V1 M4, Quality Systems for Chemical Testing. The most recent version of these proposed changes to the Draft Standard (DS) were presented during the meeting for committee as well as public comments. The Justification document as required by SOP 2-100 was also developed.

SIR Status

The committee spent considerable efforts in 2024 addressing SIRs. A number of both valid and non-valid SIR were reviewed and were presented in the above attached PowerPoint. The CEC will continue to address any SIR that remains outstanding, and any new SIR received in 2025. Only one SIR (499) remains unresolved at the present time but numerous communications with the LASEC have been completed, and the CEC awaits their approval and presentation to the AC. The documentation of resolution of all SIR are available through the TNI website.

EL V1 M4 DS Development

Bob and Michelle reviewed the process for development, review, and approval of revisions to existing Modules of the TNI Standard. Michelle reported that the CEC had, as previously presented, formed working groups to develop major sections of the module. These work groups completed and submitted their recommendations to the full committee for consideration and modification as deemed necessary. The full committee then undertook the review of the entire module, and the inclusion of work group recommendations as deemed appropriate. The following attachment provides a copy of the DS with all proposed language changes to the EL V M4-2025-Rev. 3.0. The DS has been approved by the CEC with a super majority vote (2/3 of all member ballots)



The DS, subsequent to the EMS meeting, was posted on the TNI website for comment by all interested parties. All required notifications as per SOP 2-100 were also completed.

The remainder of the meeting was dedicated to Michelle's presentation of the Justification document that must accompany the DS when posted. The document presented is attached below.



With a quorum present, a motion from Calista and a second from Denice, the justification document was approved by committee for presentation on the website posting along with the DS.

After the DS was approved, two voting members of the committee registered a "nye" vote on the DS. One, however, was not submitted with comments justifying their vote as required by SOP. The issues presented by these members as well as all other comments will be addressed during the Response to Comment (R2C) process which follows the close of the DS comment period.

The meeting was adjourned at 5:00 PM ET. The next call for the CEC is scheduled for September 3, 2025, at 2:00 PM ET utilizing Microsoft Teams.
