After a lengthy discussion and review of the Decision Tree and Certificate Contents documents we identified the following:

- Kathryn pointed out that there are no questions around thermal determinations.
  O Action: Add logic to spreadsheet
- Kathryn also posed where do thermistors fit..... Dorothy replied digital and the group agreed
  - It was also asked who in the group uses thermistors and how often are they verified? Dorothy – quarterly and a viable option is to send them out to a metrology company.
  - Action: Need to update the thermometer tab and add specs and details
- Patsy suggested that we should write a whitepaper to introduce and discuss the need for certificate requirements and a criticality decision tree
  - Patsy will draft the first whitepaper.
- Shawn Posed the question if it should it be a whitepaper (tells why we are doing it) or guide (tells how to do it). The group decided that there is a need for both.

- 1. Homework: Beta test the Decision Tree and see if the logic allows for correct determination of critical vs non-critical
- Homework 2: Use the Certificate Contents list to verify some examples of Certificates of Analysis (however named) and Verification Service documents (however named).
   Determine the ease of use and applicability to understand if a service document or certificate meets the traceability and documentation requirements necessary.

Action: CTF Chair to review ISO Guide 31 2015 for any changes from the previous version.

The CTF group discussed the potential use of these documents and decided that continued focus on review and testing of the Decision Tree and Certificates Content document with a goal to prepare a final version of each that are suitable for review and public comment.

The meeting was adjourned. The next meeting of the Task Force is scheduled for August 25, 2022, at 3:00 PM ET.
