Summary of the TNI Credentials Committee Meeting Wednesday, October 23, 2024 1:00 pm Eastern

1. Welcome and Roll Call

Ken welcomed everyone to this meeting. Attendance is recorded in Attachment 1. The agenda was approved by unanimous consent (see Attachment 2). The minutes from the September 25 meeting were approved unanimously after a motion by Theresa, seconded by Salima.

2. Update on the QMS Digital Badge Launch

The workshop on Thursday, February 6, after conference in Jacksonville, is definitely planned, and Jerry has lined up several committee members (as well as the IT Administrator) to be presenters.

The software adaptations to address courses that have homework and quizzes in addition to the "exam" still need to be worked out. Jerry will direct that, at least, TNI staff proceed with beta-testing the software, but he noted that several staff were impacted by recent hurricanes.

3. Resume Review of Technical Specialist KSA Document

§4.8 (LOD & LOQ) – discussion took place around the differing requirements of the DOD standard versus the TNI Standard, but this credential will be only for the TNI Standard. Participants considered adding a note to that effect, but the DOD standard is not mentioned as a reference, so the note was not created.

§4.9 – minor edits only.

§4.10 – 4.10.1.c mentions quality system matrix; these are only defined in Module 4, not in Module 2, but no change was made as section 3.0 (and so far, the following sections) are all about chemistry. Other minor edits were made in various subsections.

§4.11 – subsection c was clarified.

§4.12 -- no edits.

Review will resume at §5.0 for the next meeting.

4. New Business

Meeting dates were adjusted to accommodate the Thanksgiving and Christmas holidays.

5. Next Meeting

The next meeting will be on <u>Wednesday, December 4, 2024, at 1 pm Eastern</u>.
