Section 5.4.6.3 old ISO language was originally placed under ISO language 7.6.3. It was all removed because the new ISO language was preferred.

Section 5.9.1.a inserted under ISO language 7.7.1.d was removed. This old language is not needed anymore.

Sections 5.9.2 and 5.9.3 inserted under ISO language 7.7.3 were removed because they were redundant.

Scott will prepare an email to help people review Section 8. He is concerned that the Standard will not be complete by the January meeting if the Committee only relies on the 2 remaining regular meetings through the end of the year.
