# NEFAP Executive Committee (NEFAP EC) Meeting Summary March 20, 2024

#### 1. Roll call, Agenda and Meeting Minutes Review:

Tracy Szerszen, Chair, called the NEFAP Executive Committee to order on March 20, 2024, at 1pm Eastern. Attendance is included in Attachment A - there were 8 NEFAP EC committee members present and 2 Associate members. Jerry Parr also attended.

The agenda was reviewed. There were no changes to the agenda, and it is accepted by acclamation.

The February 2024 minutes were reviewed. A motion was made by Kim to approve the February 21, 2024 minutes as written with the removal of a reminder highlight. The motion was seconded by Elizabeth and unanimously approved.

- Ilona will work with Kim and Elizabeth to put a presentation together to summarize the PFAS workshop and next steps.
- DoD Incremental Sampling explosive testing ITRC. Implemental sampling is important for explosive testing. Jerry will follow-up on this. Massachusetts Military Reservation. US Army lab in Maine might be another contact. Mentioned again on 3/20/24. Jerry will do some more homework to see if he can find someone to help.
- Anand Mudambi. Sampling Presentation EPA related. Ilona will follow-up for Tracy. Environmental Sampling and Analytical Methods (ESAM) program. It went up on their website on January 19, 2024.
- Air quality sampling. Related to wildfires. Jerry will talk to Lara Phelps.
- Jerry found the presentation from NEMC with the e.coli sampler Jerry will reach out to him. Dan Anglesc. He submitted an abstract for NEMC and perhaps

- would be willing to do similar talk for the Field ConclaveConclave. Jerry will still follow-up.
- Tracy to follow-up with David Fricker about a possible talk. FSMO's in South America. Tracy is still following-up.
- Storm water monitoring. There is lots of sampling. Is this an opportunity for a session? Who? Elizabeth has a Texas stormwater committee meeting on Friday. She will look into it.
- Jerry noted that some of the abstracts coming in for NEMC could be considered for the Conclave also. The Air Session at NEMC is very field related. Jerry will follow-up with these presenters.
- Elizabeth will reach out regarding ambient air monitoring for mining. Georgia has a great state program. Reached out- the lab said no, but State of GA said maybe.
- Jerry suggested the training done this last year in Oregon on poor sampling practices could be presented at the Conclave. 30 minutes.
- Marlene can do something on Sample Planning. Maybe tie some of the new FAC Standard into this too?
- Lead Initially Jerry thought this was all lab focused. 17025 Section Only 2 sentences. Why not mention NEFAP? Might still be ASTM E15833 Lead dust paint soil. Jerry will ask William Lipps who is responsible for this and maybe there is a speaker there. Might be committee D22.1 They have a number of possibly relevant standards. Jerry will follow-up to get a speaker. 50 standards for lead. Overview of standards related to field.

Everyone needs to be working on getting these finalized.

#### 3. SOP 5-106 - SIR

Ilona reviewed the SOP and found that changes are needed, but that most are editorial. The Committee agreed so the update numbering should be 1.1 instead of 2.0. There was general agreement on the changes Ilona made.

Katie made a motion to approve SOP 5-106 as sent by email for review by the Committee. The motion was seconded by Elizabeth and unanimously approved. The SOP has been placed in the Policy Committee review file.

# 4. FAC Update

The Volume 1 Standard is essentially complete and has been sent to Jan for formatting and clean-up. It will have a final review after Jan sends it back to confirm references are correct, italic language is correct, etc ... Ilona will update the cover page, headers, history and table of contents. It will then be ready for voting.

Volume 2 went through a re-write to line it up with the current DRAFT of the LAB Standard. Matt Sica was on the FAC call, but ABs still need to do a final review.

Checklists are being revised and renewal applications will go out to NEFAP ABs end of April.
