Ilona will take the SOP and refer to the User Guide where appropriate. The User Guide should have the details on how to make a change and this SOP should guide the user in what changes need to be made.

General edits were made through 5.2.6 and lists need to be updated to bullets so the information is easier to read.

The procedure for where membership status can be viewed on the TNI member page was reviewed and confirmed.

Section 5.2.4.4 – General edits were made for readability and changed "voting member" to "elected member" throughout the SOP.

The Committee will continue its review starting at Section 5.2.6 at the next meeting. Paul noted that he will not be able to attend the next meeting.
