1. Roll Call and Minutes Review:

2. Policy 1-100 (Creating or Revising General Policies and Procedures for TNI) and SOP 1-116 (Development and Approval of TNI Policies and SOPs) Discussion

Policy 1-100:

Concerned about whether there needs to be consensus of the committees before it is Provisional.

Thoughts are that an SOP can be approved for distribution and comment. Then after comments come in , the Policy Committee would vote to approve/finalize the SOP.

SOP 1-116 does not need to be changed. Provisional and Final procedures have not changed.

3. SOP 1-102 – Voting Rules for TNI Committees

The same edits were made to SOP 1-102 that were made to Policy 1-100 regarding DRAFT review for distribution and comment.

Additional edits:

- Spell out interpretation request.
- Patsy had a question of quorum. It is greater than 50%.
- Section 5.2 bullet 5 What is initiate vote? It will be removed. Jerry will look more closely after the meeting to confirm there is no issue with this deletion.

- Section 5.3.4.6: PA instead of Program Administrator. The entire document will be reviewed for more instances.
- Section 5.3.4.7: Remove comma between "vote" and "unless" in note. Remove "affiliate".
- Section 5.4.3 and other sections: Is it Council or NELAP AC or AC. Be consistent. Use AC.
- Fixed numbering.

The NEFAP EC will still be commenting on SOP after their May meeting.

4. SOP 1-122 (Advocacy Document Control)

There are a number of changes, so it will be completely reviewed.

Summary - Delete: and the support of accredited organizations on TNI's website. Add "Advocacy" to make it clear what documents. Delete: as well as a predictable and established process."

Definitions: Report - "An" instead of "A".

Section 5:A) - remove "other prior"C) - remove "such as the Advocacy Committee"E) - "Are" instead of "will be"G) - remove "as appropriate"

5. SOP 1-126 (Roles and Responsibilities of TNI Ambassadors)

Changes were made to the Summary to read:

TNI plans to eventually have designated Ambassadors to all non-NELAP state environmental laboratory certification programs. Ambassadors are individuals <u>willing</u> wishing to represent TNI to the non-NELAP state to which they are appointed as an Ambassador. They are asked to form a <u>mutually beneficial</u> <u>standing liaison</u>-relationship with <u>the assigned</u> <u>representative(s) of the state program(s)</u> to which they are assigned and with anytheir-laboratory association(<u>s</u>). that may exist in that state, with t<u>T</u>he goal <u>is to</u> <u>ensureof ensuring</u> that the non-NELAP state certification program, and the lab<u>oratoriess</u> it serves, are aware of both TNI's ongoing activities and any new TNI programs.<u>that</u> may be useful to them. Ambassadors are also asked to inform TNI of any changes in the state certification program. Related Documents: Remove Goal 2.2 and 4.4
