4.0 Review of SOP 5-108 on Adoption of FSMO Standards

The committee made the following edits:

- Changed future tense to present tense throughout.
- Revised the definition of Expert Committee by adding the word consensus and deleting 2 process sentences
- Revised Section 5.1 by making the first sentence lead off by stating the EC conducts a thorough review.
- Removed the rest of the language in this section, making it a separate paragraph and indicating the participation in the development process is not optional.
- Changed “should” to “must” in 5.1.1.
- Removed the clause about consistency with regulations from 5.2 and deleted the next sentence about the composition of the committee.
- Revised and shortened 5.3 and clarified the NEFAP AC requests a review by Abs.
- Revised 5.4 to make this activity mandatory.
- Changed 5.5.1 to be a Note.
- Eliminated 5.10.2 as this action is covered in 5.9.
- Many other minor edits for clarity with no change in intent.
