Draft Standard Working Groups

PTEC Work Groups were established to address the required/desired changes to the PT related Volumes and Modules. The Work Groups were established as follows:

During the previous meeting, the committee worked through V1M1, Sections 3.2, 4.1.4, 4.2.2, 4.2.3, 4.3.5, 5.2.1.2a, 6.2 and 7.2. The results of those discussions are presented in the attached notes on the PowerPoint presentation.



The committee also looked briefly at Section 4.1.5 of V2M2 but had little time to come to a decision on the issue identified in this section. The December meeting of the PTEC continued to review proposed changes to V1M1 and V2M2 issues (slide 8 in the attached is the location from which December discussions began). Results of discussion or intentions to advance public input for issues debated are presented on the attached update of V1M1-V2M2 PowerPoint presentation.



Upon completion of the review of work group efforts, a new Draft Standard (DS) will be prepared, and the committee will continue through the process defined in SOP 2-100, Rev. 3.4.

New/Old Business

The PTEC continues to have a full time/voting member vacancy. Bob has solicited some existing Associate members, but none have been available to commit to the requirements of full membership. Efforts will continue to fill the vacancy.

The TNI Winter meeting is scheduled for January 9-12, 2023 in San Antonio, Texas. Registration is now open and committee members were encouraged to register. Kirstin's

schedule will prohibit her attendance and other arrangements will be made for management of the PTEC public meeting in January.

The PTEC meeting adjourned on a unanimous vote of the committee following a motion by Patrick and a second by Chandra at 12:35 AM ET. The next meeting is scheduled during the Forum on Environmental Accreditation on January 10, 2023 in San Antonio.
