### **Recent Accomplishments Covered:**

- The addition of three new voting members
- Susan Jackson assuming the role of Committee Chair
- Stacie Crandall beginning to transition into the role of Program Administrator
- The committee responded to three complaints on the Radiochemistry FoPTs
- 29 PFAS compounds were added to the Drinking Water FoPT Table and
  - A 45-day comment period was conducted to gather input from a broad audience of interested parties
  - Comments were incorporated and responses sent. Updates to the initial draft included changing acceptance criteria to 70-130% for the six newly regulated compounds and updating nomenclature to match EPA methods
  - o LAMS was also updated to ensure consistency
  - The updated Drinking Water FoPT Table is posted on the TNI website effective January 1, 2025

#### **Subcommittee Updates:**

**Chemistry FoPT subcommittee**- beginning the 10-year review process of all Drinking Water FoPTs, pending receipt of all PT Provider data uploads

Whole Effluent Toxicity Testing FoPT Subcommittee- continuing to evaluate data to make changes to the FoPT table to improve applicability of WET PTs

SOP Subcommittee- will begin SOP updates as needed with Amanda Fehr as the new chair

#### **PTPA Annual Reports**

Both PTPAs gave annual reports that included a summary of failure rates and other program performance indicators showing the PT Program remains stable

#### **Future PTPEC Goals:**

- Look for opportunities to work with non- TNI States
- Completion of PTPA evaluations
- Work with the Radiochemistry Expert committee to determine how to handle reporting of uncertainty for PT results
- Completion of any internal audit items
- Participate with the technology Workgroup as needed

#### Long term goals include:

- Exploring the feasibility of technology-based PTs
- Incorporation of preparation methods into the PT Program
