#### Whole Effluent Toxicity Testing Expert Committee Meeting December 16, 2023 1:00 pm Eastern

# 1. Welcome and Announcements

Rami welcomed everyone. The agenda (see Attachment 2 below) was approved by unanimous consent with an amendment to add re-election of Teresa as an Affiliate Member. Attendance is recorded in Attachment 1, below. The minutes of November 29 were approved unanimously after a motion by Caitie, seconded by Darrin.

#### 2. Elections

#### Continued memberships

Stephen had nominated himself for a second term by email prior to the meeting, with a second from Rami. Approval was unanimous.

Stephen nominated Caitie for a second term and Teresa seconded the motion. Approval was unanimous.

Stephen nominated Chandra for a second term and Caitie seconded the motion. Approval was unanimous.

Stephen nominated Teresa to continue as an Affliate member and Darrin seconded the motion. Approval was unanimous.

#### Vice Chair

Stephen had nominated himself for Vice Chair by email, with a second from Rami, prior to the meeting. There were no other nominations. Approval was unanimous. Stephen noted that he is unable to take on the Chair role at this time.

#### <u>Chair</u>

Rami is not allowed any time beyond his third term, which expires after conference in January 2024, but will continue as an associate member of the committee. Teresa offered to take on the chair role if necessary, but requested that a vote be postponed until the January 17 meeting in hopes that someone else will volunteer.

#### 3. Update on PTPEC WET FoPT Subcommittee

The requested data from PT providers has finally arrived, but the scheduled meeting for December failed to attain a quorum. Rami noted that one of the PT provider reports is inaccurate and that provider has now gone out of the business of providing PT samples. One committee member noted that Waters is still providing PTs, but it is problematic that DMR-QA requires only one endpoint but Waters requires all three endpoints to be reported, and asked if the committee could use its influence to have Waters require only what the DMR-QA requires. Teresa agreed to investigate that further as follow-up to her PT session presentation at the SETAC meeting.

#### 4. Revising the Module

#### **Definitions**

Review of the definitions resumes at Control Chart. Several minor edits were made to some of the suggested definitions. Definitions for False Positive and False Negative were removed and a placeholder was added for Intra-laboratory Variability. These changes are tracked in the latest version of the draft module, which is being distributed with these minutes.

### 5. New Business

There was no new business. Elizabeth moved and Darrin seconded that the meeting be adjourned, and approval was unanimous.

### 6. Next Meeting
