

## **Whole Effluent Toxicity Committee Meeting**

### Minutes

#### 1 - Welcome and Roll Call

Teresa called the meeting to order at 1305 Eastern. A quorum was not present, so Teresa asked for feedback on whether or not we should have a meeting and discuss the draft Standard and comments. Darrin wanted to make a comment about the definitions, but likely not proceed in light of the lack of quorum. That was met with general agreement. Darrin stated that there are a lot of comments on the definitions. He feels that many are compelling and how he would fix them, but feels that the information to be deleted is important. Paul explained that he wasn't clear in what he meant with saying that they should be deleted. He agrees that there's important information present, but that the information deleted from the definitions should appear in the body of Module 7 as opposed to in definitions. Paul will work at trying to find where that information should fit.
